



TEENNOW CALIFORNIA SEX EDUCATION CURRICULA LENDING LIBRARY

TeenNow California is offering members the opportunity to review curriculum materials from selected evidence-based curricula for sex education programs. We have selected a number of curricula that have met the standards of at least three authorities on sex education: Science and Success, from Advocates for Youth, Emerging Answers, from Dr. Doug Kirby and ETR Associates, and The National Campaign to Prevent Teen and Unintended Pregnancy. These materials are provided to members for review only—***copying of materials violates copyright laws and is prohibited***. If, after reviewing a curriculum, you decide to purchase it, you should return the materials to TeenNow California and order the curriculum through the company that produces it.

As we carry only a limited number of each curriculum, lending is on an as-available basis. If materials are already on loan when we receive your request, we will place you on a waiting list and you will receive the materials as soon as your name comes up on the list.

We do not charge any fees for this service, as long as materials are returned in the exact condition in which they were loaned. TeenNow California does require a valid purchase order number for the value of the materials as collateral for the loan, or a credit card number and expiration date. The PO will not be invoiced, nor the credit card charged, unless materials are not returned by the due date.*

Using the Lending Library is simple:

1. Browse through the list of selected curricula and select one or two that you are considering for your program.
2. Download, print and complete the Lending Library form.
3. Make sure you select a maximum of two curricula.
4. Fax the form, along with a valid purchase order (if using a PO) for the cost of the curriculum(a) (including sales tax), to 619-741-9643.
5. We will ship the item(s) as it becomes available. With your order will be an instruction page detailing how and when to return the item(s). You are responsible for the cost of shipping the materials back to us.

* Members not returning materials will be required to pay the cost of the curriculum borrowed, and will forfeit member benefits for one year.
